1. **Nomination of Secretary:** The President shall nominate the Secretary out of the 3 executive members elected who have at least 5 years of enrolment with the Association as on the 1st day of July, 2023.
2. The contesting candidate should not be in arrears of any dues at the time when he/she submits his/her nomination form.
3. If candidate had not attended at least 5 meetings in the relevant years i.e. from 01.07.2022 to 12.06.2023, then he/she will be disqualified from contesting the election.
